The EU chemicals regulation for **Registration, Evaluation, Authorization and Restriction of Chemicals (REACH)** came into force on June 1, 2007. REACH is designed to improve the protection of human health and the environment. The regulation establishes Europe wide uniform legal standards and replaces the former existing legislations for evaluation and notification of new chemical substances.

REACH compliance in Europe is required for all masterbatches, compounds and resins offered by Sukano AG to European customers used for the production of packaging, extruded films, profiles or injection molded parts. Sukano received the confirmation from the **European Chemicals Agency (ECHA)**, that our pre-registrations of all our relevant substances were accepted by November 30th, 2008.

Mixtures offered by Sukano AG do not contain any Substances of Very High Concern (SVHC)* (status July 16, 2019) as part of our formulation, nor are they intentionally added during manufacture.

For articles (packaging, films, profiles or injection molded parts) imported into Europe, which are made by NON-EU customers from masterbatches, compounds and resins, typically no registration and no notification obligation exists. A typical requirement is to verify that they do not contain SVHC.

We therefore guarantee full compliance with the REACH regulation for all products provided by Sukano AG to our customers in Europe. We remain in constant contact with our customers' and suppliers' REACH-Only Representative to ensure, that all REACH requirements are continue to be fulfilled as efficiently as possible in the future.
